# BUILDING NEW NARRATIVES Migration and its contribution to European society

Over the last 3 years, the MAX project, an initiative funded by the European Commission, has been working to change the narrative around the migration discourse. A total of 6 policy and research reports, two training courses on a solution-focused approach to migration reporting for over 100 journalists in 20 different countries, an online Diversity Film Festival and Award Ceremony with hundreds of candidates and more than 20 online and physical events are some of the outcomes of that work.

The MAX team believes that well-managed migration to Europe contributes to our societies, culture and economy. The integration and social inclusion of people with migrant backgrounds, refugees and asylum seekers is crucial for cultural exchange, economic development, fighting against the downward demographic slope and community cohesion. It also helps address skills gaps and labour shortages, and to boost economic performance overall. Currently in the EU, too many migrants face challenges in terms of unemployment, discrimination, non-recognition of certificates and diplomas, lack of educational and training opportunities, language barriers and limited social interaction with other local communities.<sup>1</sup>

European societies are, and will continue to become, increasingly diverse. Notwithstanding the efforts and progress made, many third-country nationals across the EU continue to fare worse than EU citizens in terms of employment, education, and social inclusion outcomes.<sup>2</sup>

The 25<sup>th</sup> and 26<sup>th</sup> November the MAX project invites you to hear and debate with us the findings of the MAX project and, most importantly, the voices and experiences of the migrants, as well as all those actors working on social inclusion and migration policies at local, national and EU levels, to continue working together for real inclusive societies. On the 26<sup>th</sup>, the role of art, culture and creativity in changing the narrative will be highlighted through film screening, music, food, literature and art exhibitions.


Project Officer at European Network of Migrant Women


#### **Gina May**

## Iffat Rose Gill Founder of The Code To Change



Iffat Rose Gill is social innovator, digital strategist and a global leader for digital inclusion of women. She has extensive experience in setting up programs and initiatives for economic empowerment of women through digital inclusion via public-private partnerships to address the shortage of skilled labor and the gender digital divide.

Ms. Gill's initiative The Code To Change is working in Europe to bridge the gender and e-skills gap in the technology industry. She has been named one of the Wonder Women of Amsterdam by city of Amsterdam. Her work has been recognized by Startup Amsterdam (Amsterdam City Council) as one of the top 10 diversity initiatives in the Netherlands. Her work has been featured in two publications by German government.1 Her recent success, The Code To Change Pakistan, has trained 900 women in digital skills and the project is now gearing up to launch an extensive program for entrepreneurs in Pakistan, in partnership with Amsterdam University of Applied Sciences.

Iffat's new venture, Digital Starling is a for-purpose company that brings together female-led founder teams with specialized digital assistants from under-represented communities. With Digital Starling, Iffat is tackling a two-sided problem: female talent is chronically underrepresented on a global scale, and many early-stage businesses cannot afford the talent that they need to scale.

Since launching the organization in 2010, Iffat has trained over 1200 women to be tech-job ready, and in the process impacted the lives of over 5,000 women. For her efforts in the field, in 2020 she has been nominated for the UNESCO Prize for Girls' and Women's Education by the South Asia Foundation.

Ms. Gill has a strong focus on up-skilling and re-skilling the current talent pool to meet the ever growing and evolving needs of the digital economy. She has been at the forefront of shaping the global policy debate of women's digital inclusion for more than a decade. She has advocated for digital and entrepreneurship skills education and gender diverse workforce at many policy level platforms, including the UN's World Summit on the Information Society-WSIS Forum, the UN's Internet Governance Forum and the European Parliament.

In 2010, Ms. Gill's project Community Technology Center for Women in Pakistan won the Syster's Award from the Anita Borg Institute. Ms. Gill has specialized in Internet Governance issues after finishing her degree in Pharmacy. In her free time, Ms. Gill loves to teach children about building and programming robots!

Durant was a member of the Senate between 2003 and 2011. As a Senator, she served on Committees for Foreign Affairs, Social Affairs and participated in many elections observation missions.

Durant became a Member of the European Parliament in the 2009 European elections. She served as Vice President of the European Parliament between 2009 and 2014. In addition, she was a member of the Committee on Budgets, the delegation for relations with Iran and the delegation to the ACP—EU Joint Parliamentary Assembly. On 15 September 2010 Durant supported the new initiative Spinelli Group in the European Parliament, which was founded to reinvigorate the strive for federalisation of the European Union (EU).

In June 2017, United Nations Secretary-General António Guterres, in consultation with Mukhisa Kituyi, decided to appoint Durant as Deputy Secretary-General of the United Nations Conference on Trade and Development (UNCTAD).
